1. **SIGN-IN/OUT**: Student must sign in and out. Participants are not allowed to exit the premises without signing out.
2. **DRUGS & ALCOHOL**: Possession and/or use of tobacco, alcohol & illegal drugs is strictly prohibited. Any youth who comes into The Landing @ C2G intoxicated or under the influence of an illegal substance, will be subject to arrest. Parents and authorities may be contacted.
3. **RELATIONSHIPS**: Public displays of affection is prohibited. No displays of affection will be tolerated.
4. **CURSING**: No use of profanity or taking God's name in vain. No use of language that is sexual in nature.
5. **WEAPONS**: No weapons of any kind are permitted on youth center property or at youth center activities. Breaking this rule will result in the notification of parents/authorities and/or loss of membership.
6. **DRESS**: Clothing should be respectable. No t-shirts or caps may be worn that have negative messages about sex, drugs, alcohol or anything else deemed inappropriate by center staff. Females will not be allowed to show neither bare midriff, nor shorts and skirts that are too short in the opinion of staff. No heavy coats or jackets will be worn past the sign-in station and will be hung in a designated area.
7. **HARRASSMENT & VIOLENCE**: No forms of harassment, physical or verbal, will be tolerated. (i.e. no name-calling, no racial slurs and no fighting). Everyone must be treated equally and a good attitude should be shown.
8. **FOOD & DRINK**: No food or drinks can be brought into The Landing/C2G unless approved by staff on duty.
9. **PROPERTY DAMAGE**: All facility property is to be respected. Any damage done to property will result in discipline, including a charge for damaged property, a discipline contract and/or loss of membership.
10. **LOITERING**: No hanging out in the parking lot area(s) or outside the facility. When a youth signs out, they are to leave the property. Failure to do so will result in parents and/or the authorities being contacted.

A CHRISTIAN PROGRAM: I agree to give my teenager permission to participate in The Landing, a Christian program designed for teenagers to deal with their hurts, hang-ups, and habits. I understand that those leading The Landing are not professional counselors or therapists, however, the leaders are there to help and encourage my teenager throughout this journey to a freer and healthier life. I understand that any information my teenager shares in The Landing is confidential with the exception of self-harm, harm to others, or others' harm to my teenager. In addition, if my teenager shares about being in an abusive relationship, proper authorities will be contacted as mandated by the state.

RELEASE AND WAIVER OF ANY AND ALL CLAIMS AS A RESULT OF PARTICIPATION IN ACTIVITIES OR SUPPORT COUNSELING OR INJURIES OR PROPERTY LOSS OR DEATH, AND RELEASE AND MEDICAL AUTHORIZATION.

The undersigned hereby attests and acknowledges that he/she is entering The Landing @ C2G with full knowledge of the potential risks, dangers and possibility of injury that may arise out of operation and activities of The Landing @ C2G. I/we further acknowledge that Come 2 Go Ministries or Associated Churches of Fort Wayne & Allen County, employed staff, volunteer staff, officers and/or directors may offer several forms of support counseling or activities which may result in injury or loss of property. I/we hereby release and fully discharges (a) Associated Churches of Fort Wayne & Allen County and all of its officers, agents, volunteers, employees, and contractors; and (b) any entity with whom Associated Churches of Fort Wayne & Allen County collaborates as part of The Landing, from any and all liability, claims, or causes of action that may be brought by Student or any other person (including Student's estate, family, successors, heirs, representatives, administrators, and/or assigns), including all liability for damage to personal property, personal injury, death, or loss arising out of or related to Student's participation in the The Landing, including damage to personal property, personal injury, death, or loss that is caused by Associated Churches of Fort Wayne & Allen County's negligence.

RELEASE AND MEDICAL AUTHORIZATION: In the event of an emergency, if the parents/guardians or emergency contacts cannot be reached, I hereby give permission to transport my child to a hospital for emergency medical or surgical treatment, and I agree to accept any and all financial responsibility for such treatment. I wish to be advised prior to treatment by the hospital or doctor, if possible.

LOCAL TRANSPORTATION PERMISSION RELEASE: I/we give permission for The Landing staff and volunteers to transport my child to and from local activities within a 50 mile radius of The Landing. I understand that parents/guardians will be notified before any such trip is taken so that I am aware of my child's whereabouts. I further understand that we will hold harmless the driver of that vehicle by the guidelines contained in the above HOLD HARMLESS AGREEMENT.

MEDICATION RELEASE: I/we give permission for The Landing staff and volunteers to administer the following over the counter medications.

Aspirin, Pain Reliever, Ibuprofen, Cough Drops, Triple Antibiotic Ointment with Band-Aids/Gauze, Antihistamine (AKA Benadryl - used for Allergic Reactions Only)

MEDIA RELEASE: During many of our events and programs, The Landing staff will take groups pictures, activity pictures and or video for differing purposes and/or Social Media. I give my permission for Associated Churches of Fort Wayne & Allen County to use my child's picture/media in marketing, publicity, and other public means. I realize the media will never be used in a negative way and may be used in such items as newsletters, newspaper articles, thank you cards, social media and the web site. I realize this release allows my child's picture/media to be used as deemed appropriate by the staff.
